Adapted sports in getting more and more attention within the province of Fryslan and the municipality of Harlingen set a goal in the 'Kadernota sport en bewegen 2017-2020' with one of the main points adapted sports. Where by the municipality throughout a fitting sport and physical movement offer are willing to make sport and physical activity more accessible for people with a mental and/or physical restriction.

I got the assignment from my internship place to do research about the offer of sports and physical movement for people with a physical restriction now in Harlingen followed-up with an advice and implementation plan to execute for the municipality in the upcoming years. For this assignment I searched for contact with local sport organisation about their physical movement offer for people with a restriction. Here by using their social role in society to use make people more healthy one hand but more important using sport as a mean on the other side. Getting people together through sports and/or physical movement. Next to this searching for opportunities outside the local area and finding best practises which are being used in similar situations. I worked as a sport professional on this tasks with respect towards all organisations and people, taking responsibility in questionnaires and structure, but also have a critical thinking mindset to look for opportunities and pitfalls creating an SWOT-analysis. During this process I tried to improve myself in the communication, professional mindset (taking initiative and responsibilities) and improve myself in general as consultant and (sports) professional. This resulted in a 30 page report within there a field and desk research. Giving advice on how to approach the situation which is there now and how to direct this into a situation where sports and physical activities are accessible for everyone including individuals people with a physical restriction. This followed-up with an extensive implementation plan. The report(s) where received very positively by the municipality of Harlingen, seeing potential in the written plan. Being (positively) surprised of the work that was delivered.

In general I was happy with the result scoring a 6,6 as grade on the report, but it missed some small details, which I had done during my internship ship and was obvious for me and my internship host, but I didn't wrote it down in report. Through this missed some points which I shouldn't had to miss. For the next time I would start earlier with the questionnaire because it takes some time to get all responses and if I had more time I would chose for doing also a needs scan.

My task in this was to do research followed-up with an advice and implementation plan about the sport and physical movement offer for people with a physical restriction for the municipality of Harlingen. Here for I designed a action plan and strategic frame first which have been spoken through with internship coaches at school and at the internship. This to make the best possible methodical approach for the research, which steps, methods and strategies to use and which not. After this I executed the action plan using a field and desk research, completing a internal and external analysis. I did the research independently using allot of different (scientific) sources and best practices to make an as much tailored advice as possible. Being critical during meetings, questionnaire, internal documents and external sources/documents/articles. During this process I made contact with multiple professionals to read along, or ask for feedback and advice for approaches. This because of the local knowledge from most of the professional, which result in a more efficient approach. During these contacts I shared my knowledge and ideas and was open for their visions on this and (critical) feedback. Working as knowledge worker, but also using a methodically approach. The result was an well-structured report being back-up with scientific resources. best practices and local knowledge. Being build up clear and using different points of view. The report(s) where received very positively by the municipality of Harlingen, seeing potential in the written plan. Being (positively) surprised of the work that was delivered.

I was happy on the perspective as knowledge worker and methodology. It was clear to read and being underpinned strong. For the future I should make more use of professionals and/or experts, because of their high expertise on certain topics and which can also result in sharing my knowledge more often.

We tackled the assignments with a structure where we brainstormed together at first, than give everyone a task to work out and after 3 or 4 days meet again a present the task you where given and let everyone give feedback to improve it even more. Finishing it all together at the end of the week and making a presentation. During this structure we worked along with each other very well having a strong collaboration, trying to get a win-win situation everything by letting people do what they are good at. This created an efficient, positive and valuable work environment. This environment made is also easy to discuss issues and visions with each other. Where everyone was positioning themselves in a way to search for solutions and services to provide for each other. The result of this was that we ended up winning 2 of the 4 presentation, including the end presentation for an alderman in the council room of Groningen. This also showed allot of appreciation on our products and presentations. Getting good and structured feedback on the presentation and content which was provided by us.

I was very happy with the result it self together with my team. I learned allot from the other team members, having a great time together and showing a good relationship with each other. Building the network for later courses and project to be able to work to getter again. If I look back at that course I would take out to taken out more time for certain assignment to improve the quality even more. Keeping improve my own network is also important I protentional could have been in contact with more professionals during that course.

In deliberation with my internship coach we came up the topic and I would be executing the research and give advice. A couple of my tasks to get as much information as possible was to observe during meeting and to mingle in during these meetings, design a questionnaire and to get into contact with professionals and experts. It was also important to get in contact with local professionals because they know how things work and work out around Harlingen. Allot of this lead to oral conversations, such as during the meetings and contact with professionals. Other communication where done various methods as phone, mail and the questionnaire (google forms). During the oral meetings I paid respect to everyone and adapted myself during formal and informal conversations. I listened to everyones opionions and vision and tried to think along as much as possible and giving my own input back to the conversation, position myself in a way to get most information. I tailored my way of communicating to the target group, such as the questionnaire after feedback from a colleague. During the implementation plan I show knowledge from various communication ways and advice different kinds of communication to use for different target groups and situations. The result of this is that I improved myself in this compentence which I set myself as improvement point at the start of the schoolyear. Improving formal speaking in Dutch and English and increasing my vocabularies. This is improvement is also seen by various classmates after asking feedback on this points, which can be found in the reflection report.

I am happy with the improvements I made through the internship period, although I still want to improve my grammar and English speaking more. I made big steps the last year and I still have steps to take, but I'm more convinced in myself than before which helps allot.

Translating this into a product although the cultural differences was certainly a good struggle but very worth it. I improved my English allot, got allot of confidence out of that week and also collaboration in a group on intercultural level was something new with this many nationalities.

Using collaberations between all parties, keeping in mind the financial-economics, social and cultural factors in mind. This resulted in an advice where collaboration is the key factor and good communication. The advice was recieved very well by the municipality, with positive feedback on the presentation. Finding it a well thought through advice designed in a short time table.

For me this is a good example because the multiple different parties which are involved in this research and having to deal with multiple isues and factors on social, moral, cultural and finance. This was a period where developed myself extremely much in different factors where is wasn't conscious off. I am very happy with these steps made into a professional. For the future I would take more time conversations and approaches, to be more involved.
